

Terms and Conditions

Introduction

- These are the rules for the Fyffes Ireland competition for the chance to win 1 year free use of Metrifit Athlete Monitoring System, plus consultation and Fyffes/Metrifit uniform for the overall winning team.

What is the Promotion?

- The promotion is a competition to win the Prize described below (the Promotion).

What is the Prize?

- First prize is 1 year free use of Metrifit Athlete Monitoring System plus 1 Metrifit training session for coaches and/or staff, 1 fitness testing session on the winning team's training ground, 1 nutrition workshop and sponsorship of the winning team's uniform (jersey, shorts, and socks).
- There will be 5 runner-up prizes, all of which are 1 year free use of Metrifit Athlete Monitoring System, but without the above consulting services or sponsored kit.

Who can enter?

- This prize draw is open to Republic of Ireland and Northern Ireland sports clubs and teams aged 14 and over.
- This draw is not open to employees, partners and associated agents of Fyffes or Metrifit or anyone concerned with this promotion. Bulk entries made from trade, consumer groups or third parties will not be accepted.
- To claim the Prize, the team or club must be entered/ entering into an active league.
- The Promoter reserves the right to verify any details of any entrants or winners.

How to enter the Promotion?

- To enter, entrants send in a written piece explaining why they deserve to win. Entrants are also allowed to upload supporting images or video, however this is optional.
- All entries must be submitted through the designated web page. Entries will not be accepted through Facebook, twitter or any other social media, email, or post.
- No purchase is necessary to enter.

- Any third party entries or entries submitted by agents will not be accepted.
- Entry instructions are deemed to form part of the terms and conditions and by participating in the Promotion all entrants will be deemed to have accepted and be bound by these terms and conditions. The winner's guests must also comply with these rules.
- Any entrant who's comments or material contained in an entry that is deemed offensive, abusive, illegal or derogatory or which use profanity shall be disqualified.
- Entries that suggest or encourage irresponsible behaviour or illegal activity are not permitted.
- The Promoter reserves the right to flag to its social media teams any posts, photos or material related to the Promotion or any entries that could be regarded as graphic, obscene, defamatory, profane, explicit, racist, abusive, illegal or offensive in any way.
- Entries must not contain or refer to any third party brand or competitor of the Promoter and must not contain or reference any third party names, logos and/or trademarks.
- The Promoter reserves the right to contact an entrant or any other party referred to in the entrant's submission for further clarification or verification where required.
- The winner's guests must also be residents of the Republic of Ireland or Northern Ireland. Proof of residence and age will be requested.

What's included and what's not included in the Prize?

- The First Prize includes:
 - 1 year free use of Metrifit Athlete Monitoring System
 - 1 Metrifit training session for coaches and/or staff
 - 1 fitness testing session on the winning team's training ground,
 - 1 nutrition workshop
 - Sponsorship of the winning team's uniform (jersey, shorts, and socks)...
- Runner-up prizes include
 - 1 years free use of Metrifit Athlete Monitoring System, without the consultancy and training sessions from Metrifit or the sponsored jersey, shorts and socks.

- Winners must claim the prize within 30 days of winning, Metrifit will then contact the winning team to organize when their consultants will visit the team according to the best suitable dates for both the team and for Metrifit.
- In the event that Fyffes or Metrifit cancels the prize due to situations beyond their control, alternative prizes of the same value will be given.

What is the closing date?

- The closing date for the draw is **20th October 2017**. All entries must be received before midnight Irish Time on the closing date.
- The Promoter's decision about whether an entry has been received in time will be final.

How will the winner be chosen?

- Winners will be selected by an adjudication panel.
- The adjudication process will be carried out by Fyffes and Metrifit and all decisions are final.
- No correspondence will be entered into regarding the judging process and the decision of the adjudication panel will be final.
- Fyffes and Metrifit do not commit to notify unsuccessful entrants of the competition or to return unsuccessful entries.
- The winners will be notified by telephone or email within 7 days of the draw date. If contact cannot be made within one month the prize will be forfeited and may be passed on to other entrants. It is the winner's responsibility to notify Fyffes of any change in contact information.

How will the winner be notified?

- The Promoter will use reasonable efforts to notify the winner by emailing them before 11.59pm on 27th October 2017 (Irish time).
- The winner must respond to this communication within 7 days as instructed, or they will automatically be disqualified and another winner will be chosen.

When will the winner be announced?

Post Promotion Publicity
